Proposed project for 2016 (January 2016)

Decisions and Action Items

- Updated the YMAC Terms of Reference
- Published a joint response with other unions to the Ottawa Citizen dispelling the myth of young workers supporting cuts to sick leave.
- Made an ATIP request on the distribution of precarious work and employment trends in the public service for future analysis
- Established the inter-union Public Sector Youth Caucus with the youth leaders of PSAC and PIPSC, hosted the first meeting of the Caucus, and drafted its Terms of Reference
- Spearheaded the successful motion to explore options for the progressive dues structure at CAPE
- Conducted an outreach session at local university on employment in the public service, the importance of labour unions, and workers' rights in the public service
- Helped to promote the youth and precarious employment educational event organized by the Education Committee

Elections and Resolutions Committee Report by Tannis Bujaczek

- In Fall 2015, the ERC oversaw a successful by-election for one vacant EC Director position on the NEC, and the presentation of one resolution to the general membership.
- Key activities related to the by-election included: reviewing EC director applications; finalizing the list of approved candidates; obtaining and approving candidate biographies and one additional piece of campaign literature; setting the timeline for the by-election including the voting period; setting the rules for the all-candidate debate; working with the communications team as appropriate to publicize the by-election; approving the voting system; finalizing the election results; and informing the candidates of the final results.
- Key activities related to the resolution included: reviewing and finalizing the draft resolution; setting the timeline for the voting process; approving the voting system; and finalizing the voting results.
- Both the by-election and the vote on the resolution were a smooth process; no complaints were filed during the process, and no appeals were filed relating to the results.
- However, this process did continue to highlight the weaknesses and gaps in our relatively light electoral frameworks, and it will be a priority of the ERC in the upcoming year to look at how the structures can be formalized and elaborated in order to ensure clarity and fairness in these processes.
- My thanks for the ERC members, who were highly engaged during this busy fall, and to the dedicated staff at CAPE - especially Isabelle and Patrick - who showed great leadership and dedication in their work, and without whom this process could not have been completed.
