- served on both the Collective Bargaining Team (where we helped stave off the atrocious health care plan proposed by the Conservatives, were able to negotiate a modest wage increase, and embedded crucial elements such as the right to professional integrity in your current collective agreement), and on an member/member complaints committee, as well as participating in various events either representing or with ACEP-CAPE.

I WILL (If re-elected as one of your EC NEC Directors):

- continue to work collaboratively within the NEC structure to ensure that the best decisions are made for the collective membership on the basis of the collective need and will.

In the current environment, particularly in respect to the ongoing Phoenix debacle, it is crucial that CAPE members have impartial, accurate and timely information and representation both at a Local and a National level. I will continue to act on behalf of the CAPE membership from this perspective.

While providing an advocacy/challenge function is often neither a popular role nor a fun role, combined with providing direct concrete services to members, it is a role that has seen some results.
